**Mobilizing international support to counter
Israel's attempts to expand its aggressive and
escalatory actions in the region**

The Council of the League of Arab States at the level of Permanent Representatives,

In its extraordinary session held at the General Secretariat headquarters on Sunday, November 24, 2024, under the chairmanship of the Republic of Yemen, at the request of the Republic of Iraq, and with the support of all Member States, concerning the note of the President of the United Nations Security Council dated November 18, 2024, which circulated the letter from the Foreign Minister of the Israeli Occupation Government about his allegations of increased attacks on Israel from Iraqi territory as a justification for further escalation and expanding the scope of war in the region,

- Having reviewed
 - The note of the Secretariat,
 - The note of the Permanent Representatives of the Republic of Iraq No. N/3/4/3218 dated November 21, 2024,
- Reaffirming all previous resolutions and statements issued by the Councils of the League of Arab States at the Summit, Ministerial, and Permanent Representatives Levels concerning the right of the Palestinian people to establish an independent state, the cessation of Israel's flagrant violations and brutal aggression against Palestinian and other occupied Arab territories, and the immediate halting of aggressive actions by Israel (the occupying Power),
- Reaffirming the resolutions adopted during the Joint Arab-Islamic Summit in its extraordinary sessions held in Riyadh in November 2023 and November 2024,
- Referring to the two identical letters submitted by the Deputy Prime Minister and Minister of Foreign Affairs of the Republic of Iraq to the Secretary-General of the United Nations, the President of the Security Council, the High Representative of the European Union for Foreign Affairs and Security Policy, the Secretary-General of NATO, the Organization of Islamic Cooperation, and the permanent members of the Security Council on November 21, 2024, which conveyed the deep concern of the Iraqi government regarding Israel's (the occupying Power) continued escalation and its repercussions on international peace and security,
- Commending the Government of the Republic of Iraq for its steadfast adherence to a policy that prioritizes the sovereignty and sanctity of its territories, refrains from interfering in the internal affairs of other nations, and firmly rejects the use of its lands and airspace in any regional or international conflicts,
- Lauding the firm stance of the Government of the Republic of Iraq, consistently reaffirmed, that the decision to declare peace or war resides solely with the Iraqi Government, and that it continues to prevent the use of Iraqi territories for the launch of any attacks, resulting in the seizure of weaponry intended for launches, and directives to security institutions to legally pursue all involved in activities that threaten Iraq's security or territorial integrity,
- Recognizing the Iraqi government's commitment to international law and the principles enshrined in the United Nations Charter, and calling on all stakeholders to reject any form of escalation, urging them to prioritize adherence to the fundamental principles of international law,

- 1- Condemns Israel's (the occupying Power) attempts to expand its aggressive actions in the region, including Iraq, as reflected in the letter of the Israeli occupation's Minister of Foreign Affairs to the President of the Security Council on November 18, 2024, which the League Council views as blatant efforts to justify Israeli escalation, broaden the scope of the war, and divert attention from ongoing crimes against the Palestinian people and aggressive actions in the Lebanese Republic and the Syrian Arab Republic;
- 2- Denounces the ongoing crimes of aggression, genocide, and ethnic cleansing perpetrated by Israel (the occupying Power) against the Palestinian people, along with acts of aggression on the territories of the Lebanese Republic and the Syrian Arab Republic, which have resulted in significant loss of life and property and constitute flagrant violations of international humanitarian law and war crimes necessitating international accountability;
- 3- Warns of the dangers posed by Israel's comprehensive escalation, which threatens to ignite a large-scale regional war undermining security and stability; and renews the call for the international community, particularly the Security Council, to fulfill its legal and moral responsibilities to curb Israel's aggressive policies in accordance with international law and relevant international resolutions;
- 4- Condemns the Israeli occupation government's practices toward the United Nations, including its unprecedented escalation against UNRWA, the designation of the UN Secretary-General as persona non grata, and its systematic targeting of UN peacekeeping forces (UNIFIL), which collectively demonstrate behavior that does not qualify it to address the United Nations and necessitate the Security Council's adoption of deterrent measures to halt these actions;
- 5- Condemns Israel's ongoing attacks targeting residential neighborhoods, buildings, and civilian facilities in the Syrian Arab Republic, while rejecting the fabricated allegations and falsehoods propagated by the Israeli occupation to justify these attacks and expand the scope of aggression against regional states, thereby threatening both regional and international peace and security;
- 6- Denounces the Israeli occupation authorities' excavation of trenches and construction of earthen berms along the ceasefire line, as documented in UNDOF reports; warns of the grave implications of these actions, which violate Security Council Resolutions 242, 338, and 497, as well as the 1974 Disengagement Agreement; and urges the Security Council to fulfill its responsibilities to end all practices aimed at solidifying Israel's occupation of Syrian territories and further annexing them;
- 7- Strongly condemns the United States of America's fourth veto against a Security Council resolution calling for an immediate, permanent, and unconditional ceasefire in the Gaza Strip on November 20, 2024; and urges the United States to reassess its biased stance toward the Israeli occupation, which undermines the Security Council's mandate to maintain international peace and security and delays the cessation of Israel's crimes against the Palestinian people;
- 8- Requests the Secretary-General of the United Nations and the President of the Security Council, each within their respective mandates, to fulfill their international responsibilities to maintain peace and security, take all necessary measures under Chapter VII of the United Nations Charter to halt Israeli aggression in Gaza, the West Bank, and the Lebanese Republic, as

well as attacks on the Syrian Arab Republic, and to obligate the Israeli occupation government to cease issuing threats to expand the war while respecting the United Nations and its resolutions;

- 9- Welcomes the decision of the International Criminal Court issued on November 21, 2024, which includes arrest warrants for the Prime Minister of the Israeli occupation government and the former Minister of the Occupation Army; and urges all States Parties to the Rome Statute to cooperate fully with the Court while refraining from politicizing its decisions;
- 10- Applauds the announcement by the Government of the Republic of Iraq affirming that its armed forces and all security services will prevent and prosecute any military activity conducted outside the framework of state authority;
- 11- Requests the People's Democratic Republic of Algeria, as the non-permanent Arab member of the United Nations Security Council, in coordination with the Republic of Iraq, to follow up on Iraq's complaint to the Security Council against Israel;
- 12- Mandates the missions of the League of Arab States and requests the Councils of Arab Ambassadors in friendly nations to intensify efforts in mobilizing international support against Israel's (the occupying Power) aggressive actions;
- 13- Requests the Council of Arab Ambassadors in New York, in coordination with the League of Arab States Mission and the Permanent Representative of Algeria, to sustain efforts to convene an emergency Security Council session, advocate for a resolution under Chapter VII of the UN Charter obligating Israel to immediately halt its aggression and escalation, and encourage the General Assembly to review Israel's participation freeze in UN meetings pursuant to Articles 5 and 6 of the Charter, as stipulated by resolutions of the Arab and Joint Arab-Islamic Summits;
- 14- Requests the Secretary-General of the League of Arab States to address a letter to the President of the Security Council and the Secretary-General of the United Nations, articulating the League's support for Iraq, rejecting the claims in the Israeli Foreign Minister's letter, and demanding urgent action to curb Israeli escalation, while calling for its circulation among UN member states;
- 15- Tasks the Secretary-General of the League of Arab States to follow up on the implementation of this resolution and submit a progress report to the League of Arab States Council at the Ministerial Level in its upcoming session.
